OVERVIEW:

Leading global operator specialised in the complete management of renewable assets for the generation of electricity is looking for a Project Management to be in charge of planning, organizing and managing all documentation and communication to obtain Building Permits, Environmental authorizations, other minor permits, easements, licenses and consents required for the development and implementation of PV and BESS Projects in Germany.

This role will also ensure that those procedures comply with the German Legislation, FRV internal ESG rules and possible lender's requirements.

RESPONSIBILITIES:

As part of the Germany team this position will be accountable for the following tasks:

- Together with the Development Manager, managing the overall permitting workstream of several PV and BESS Projects during inception and until Readyto-Build Status.
- Screening at the early phase of development, initial assessments and due diligence investigations. Filtering of projects. Keep the Origination and Development team informed of project risks identified during any stage of development.
- Lead the Environmental studies required by German Law and industry best practices.
- Engage with relevant stakeholders. Manage land use rights, including site control, servitudes and wayleaves.
- Managing technical Specialists, Engineers, Advisors and other external service providers to ensure the monitoring, site visits, documentation and permit appliances are undertaken according to agreed terms of reference, timelines and budgets and according to legal requirements.
- Develop and maintain permitting databanks.
- Critically review and manage specialist assessments to ensure they meet the relevant protocols and all applicable legislative requirements to reduce risk and overall impact to the project.



- Working with external lawyers to formulate responding statements/appeals if required.
- Engagement and liaison with Project stakeholders, both internal and external, including Development partners, Environmental working groups, Environmental conservation agencies, local municipalities and National Government officials.
 Presenting and answering questions at public meetings if required.
- Support office administration and contracts management.
- Assist the Managing Director of the Unit in presenting reports to senior executives, stakeholders, and board members.
- Other ad-hoc duties.
